Subject : Complaint against the husband of DEO(F) Manserha. (Mr. Jaleel.)

Respected Sir,

I have the honor to submit a request for kind consideration,

That I am performing my duty as Dy.DEO(F), from last 11the months, I work as per rule and due to my work style my DEO(F) Mst Rehana Yaseen is creating difficulties for me to disturb my routine office work, to achleve her goal she transfer my class- iv office boy without any replacement, and recently she has transferred my driver from my office without my consent to SDO Office Oghi where no official vehicle is available, I have neither office boy (class-iv) for office work nor driver for my official vehicle.

In financial matters she is not fair, up till now in three realizes of POL (the budget amount for vehicle repair, fueling and TA/DA), she withdraw all three releases and not even a single penny granted to me, this office has two official vehicles one for DEO and one for Dy.DEO the POL release should for each vehicle, being the competent authority she used her powers and utilize all amount for herself, now as the month of June is coming she is mentally torturing me so that in stress I could not demand in financial matters, in continuation to previous hurdles from last two weeks Mr Jaleel (the husband of DEO(F) Mst Rehana Yaseem) is very much disturbing me, he have given me the life threat and many times says that I always have a loaded gun I am from armed force and to a kill a person is a little task for me I will shoot and go to KARRAK.

The office staff consider him as guest and give him due respect but he could not grasp the honor, he misbehave and passes immoral remarks to the female teachers who come to office with their day-to- day issues, it is also totally against our society norms that a man passes immoral remarks to female, I am very much marvel that why not the civil society is taking it serious. the said person is a blackmailer and want to take the whole charge of the office and I work as per rule and due to my work style Mr Jaleel and DEO(F) are against me, every new day she issued me baseless explanations, the explanations written reply with documentary evidence was submitted when she did not find any point against me she used her husband and send me court notice of defamation, which is completely baseless, Mr. Jaleel himself always speak abused language and interfere in official matter(The latest proof of this type incident is the Newspapers cuttings) (Newspaper cutting attached)

When he was asked to don't interfere in official matters, he became confound and used very abused language for me and hide his own wordings from his wife and complaint about me, she did not argue with her husband and used her designation and powers to insult and torture me and to prove her husband innocent by time to time baseless explanations which all are for personal revenge and not for correction, on her husband's complaint she send me menacing message "تم انتہائی بد مزاج عورت ہو اس کا جواب دوں گی" (Tum intahi batamez aurat hoo es ka jawab dongi) You are a bad-mannered women and I shall retort you", which

means that you have stopped my husband to interfere in official matters I shall retribute you,

After this incident she make more hurdles for me, I am feeling very much unsecure from both Mr. and Mrs Jaleel about my job , life and repute.

I am resident of Abbottabad and dally travel in local van from Abbottabd to Manshera, being a female after the threat of Jaleel I am feeling myself very much unsecure,

Therefore It is humbly requested that keeping in view above mentioned facts a quick a serious action be taken against this situation, and legal action taken against Mr. Jaleel as per harassment act, moreover if any mishap during my travel or in office occur DEO(F) Mst Rehana Yaseem and her husband Mr Jaleel will be responsible.
